Possible Closed Session: Please take notice that when considering the following item, the Ethics Board may go into closed session from time to time pursuant to secs. 19.85(1)(a), and (1)(g) Wis. Stats., which read in relevant parts:

(a) Deliberating concerning a case which was the subject of any judicial or quasi-judicial trial or hearing before the governmental body.

(g) Conferring with legal counsel for Ethics Board who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved.

Further take notice that, if the Ethics board goes into closed session, it may return to open session immediately, without giving the 12 hours notice under sec. 19.85(2), Wis. Stats
